(PSYCHIATRIC DIAGNOSIS OF GANA KIRITHARAN'S MENTAL CONDITION.)

I, Gana Kiritharan, of City of Toronto, of Province of Ontario, the Plaintiff in this action,

MAKE OATH AND SAY AS FOLLOWS:

- 1. The Fraudulent Interferences I experienced in my attempt to become a Freelance writer made me to feel stressed and depressed many time. (Affidavit of Document 9 Civil)
- 2. But I was able to control the damages by listening music, traveling, reading books and taking enough rest.
- 3. But when I failed to receive clear explanation for my concerns from TD Canada Trust (Affidavit of Document 3 Civil) and Toronto Police Services failed to accept my fraud complaint around April 2007, I felt extremely depressed and also experienced severe Peptic Ulcer Symptom.
- 4. Also as I has Family History of Suicide I decided to go for help from a Psychiatrist.
- 5. I requested for a referral from my Family Physician (Dr. Selvanathan) and as he refereed me I went to the care of Dr. Sooriabalan.
- 6. On my first visit to the Hospital, Dr. Sooriabalan, after listening to my story, he gave me prescriptions for two medications. He informed me one Medication is for stabilization of my mood and next one is my problem of depression.

- 7. The medication given for stabilization of my mood, when taken made me to feel extremely tired and sleepy. After taking for two weeks I stopped taking it.
- 8. I continued to take the medication for depression.
- 9. While under care of Psychiatrist I continued to experience stress and related physical symptoms.
- 10. When I requested for care for these issue, my psychiatrist and general physician referred me to Gastro Intestinal Sergeant and Group therapy.
- 11. The treatment and advises I received helped me to feel better.
- 12. I was in a believe that I was being treated by Doctors for Stress and Depression only.
- 13. But when I requested for a Diagnostic Letter from Dr. Sooriabalan (my psychiatrist), I got a letter saying he diagnosed me with "Delusional Disorder of Persecutory Type." Though this letter dated 4th June 2008, I picked it up from Counter of Rough Valley Health System Psychiatric Department only on 22nd of July 2008. I failed to receive any call saying the letter is ready for me at the counter.
- 14. On 29th of July 2008, I forwarded a letter to Dr. Sooriabalan saying his diagnosis may be a mistake because of his poor common sense in accounting, banking and credit reports and his failure to carefully analyze the evidence I saw him that I am a Victim of Fraud and asking him revise the diagnosis. I also included my believes in the Civil Action against TD Canada Trust, Evidences for that I am a Victim of Fraud and Other Necessary Legal Documents with this letter. I failed to receive any reply for this letter until 12th September 2008.
- 15. On 18th of September 2008 when I went for an Outpatient Clinical appointment with Dr. Sooriabalan, I brought the issue again to the attention of the doctor. Then Dr. Sooriabalan informed me If I wish I can go for a second opinion with another Psychiatrist. Then I gave him a letter asking to discuss my clinical presentation with other psychiatrists in the hospital also asking to answer a questionnaire which may help to understand the impact of his diagnosis in the Civil Case I have filed against TD Canada Trust.
- 16. Then Dr. Sooriabalan informed me he will discuss with other psychiatrist in the hospital and will find another Psychiatrist for a second opinion in my case.
- 17. Also Dr. Sooriabalan retuned my letters dated 28th July 2008 and 18th September 2008 also the questionnaire I requested to answer back to me.
- 18. Also Dr. Sooriabalan informed me he did not give a diagnostic letter to any other party.
- 19. As I has a believe the diagnosis of Psychiatric illness for my mental condition may started as early as 2003 March April, to verify my believe, I forwarded enquiry letters to Family

physician I have seen in Canada namely Dr. Harrison Christine (Ottawa; Year 2000 - Year 2003) Dr. K. Vaithianathan (Scarborough; Year 2004 - Year 2005) Dr. M Selvanathan. (Scarborough; Year 2006 - Until Now). The Response received as follows:

- Dr. Harrison Christine: The mail send my me get returned to me with a note saying "Dr. Harrison Christine no longer work in the Ottawa University Health Center" where I have seen her in the past.
- ii) Dr. K. Vaithianathan: Doctor informed me he need a letter from present family physician, then only he will forward my treatment details to him.
- iii) Dr. M. Selvanathan: Doctor informed me there was no incident as I suspected.
- 20. I also contacted following Lawyer to know whether this diagnosis was used to interfere into my legal rights and get informed as follows:
 - Ms. Barbara Jackman: As the date I contacted them is 4years old, they could not i) remember any incident.
 - ii) Mr. David P. Lees: No such an incident has happened, If so I would have been informed by them.
 - iii) Mr. P. Kayilasanathan: No such incident has happened.
- 21. I also contacted CB Associate and Consultants, whom I have hired to correspond with TD Canada Trust regarding my line of Credit between 7th of September 2007 and 16th of October 2007. I forwarded the letter by Xpress Post on 24th September 2008. Any reply will be included in future affidavit.
- 22. I am enclosing copies of the letter I have send to different people and my Psychiatrist's diagnostic letter with this affidavit.

Psychiatric Report

I Dr. T. Sooriabalan, MBBS, M.R.C. Psych(UK), FRCP(C) currently working as a consultant psychiatrist at Rouge Valley Health Centre, Toronto which to provide the following psychiatric information at the request of Mr. Kiritharan.

Mr. Kiritharan was initially seen in consultation on May 30, 2007 referred to us by his family physician Dr. Selvananthan.

Following my interview as well as the Mental Status Examination I came to the conclusion that Mr. Kiritharan was suffering from a major psychiatric illness called Delusional Disorder of Persecutory Type and the treatment given included medications in the form of Zyprexa/Zydis 5 mg. daily and Cipralex 10 mg. daily as well as supportive psychotherapy. The Zyprexa/Zydis is an atypical antipsychotic medication and Cipralex is an antidepressant.

Following the initial consultation Mr. Kiritharan has attended the Outpatient Department on the following dates July 26, 2007, October 25, 2007, January 24, 2008 and May 2, 2008.

As far as the medications are concerned, Mr. Kiritharan informed me that he stopped taking the Zyprexa/Zydis after two weeks of trial. His current medication is Celexa 20 mg. daily which is an antidepressant.

Dear Dr. Sooriabalan,

I, Gana Kiritharan, am a Patient under your care for my mental disturbances from May 2007. Recently I requested for a Diagnostic Report about my mental condition for some legal purposes. I received your Psychiatric Report dated June 4th 2008 on 22nd July 2008. I am surprised to see that you have diagnosed me as a patient with Delusional Disorder of Persecutory Type. I feel your diagnosis is a mistake because of your poor common sense in accounting, banking and credit reports and your failure to carefully analyze the financial documents I saw you as evidences for that I a victim of Fraud at the initial Interview with you.

In my opinion, my believes in this problem will not fall under criteria "The belief is, at the least, unlikely" which may be important for diagnosis of Delusions. I am enclosing "My Believes, Evidences for that I am a Victim of Fraud, Other Legal Documents and Case Summary, Court Orders and Police Report of Civil case I have filed against TD Canada Trust who may an important party in Conspiracy against me. When I challenged TD Canada Trust in Court for concealing money belong to me, they replied that my challenge is frivolous and vexatious and has not advanced a cause of action known to law. In medical term you can interpret it as "Delusions and Hallucinations". But so far TD failed to move an action in the court to prove their argument.

I would like to ask you go through my documents carefully and revise your diagnosis of my mental condition. I tried to get a professional evaluation from a Charted Accountant of my evidences. But I am unable to do it immediately as it may cost lots of money and as the matter already in the court, accountants may preferred to do it under court instructions. If you are unable to evaluate my financial documents for one or other reason please let me know so that I can request the court to send my accounting details for evaluation by a neutral Charted Accountant for which I need some money and time.

If your Diagnosis falls into the wrong people hand they may use it to deny my legal rights and create obstruction to Justice, which is serious criminal offence. Because of this I would like to ask you to give me your reply in writing as early as possible. Please ask your staff to inform me by Phone when your reply is ready, so that I can Pick Up from the Counter.
