I, Gana Kiritharan, would like to bring your kind attention of an organized conspiracy I am experiencing into my financial and Intellectual life and the civil action I have filed against a Canadian Bank **(TD Canada Trust)**, who may be an important part of this conspiracy and have some important evidences. I came to Canada in 1999 with a dream to become a writer. I wrote my first book after one year coming here and it is got published in 2003 and now runs 5th success year of sales. (Please visit www.gkiri.com for more information about the book). Unfortunately I had to face some organized conspiracy when coming to royalty payment. Someone else opened an account in my name in TD Canada Trust criminally and cashed my royalty cheques.

When I realized this issue and started to search for legal help, tellers at TD Canada Trust printed some additional information on the back of the Transaction Slip (Voucher) I signed. I was prevented from looking at this additional information. According to Court order bank still has to produce two of the original of Transaction Records (or Slips). These Transaction Records or Additional Papers attached to it may contain some printed information regarding Royalty belong to me.

Also when I defaulted my Line of Credit with TD Canada Trust after 7 months the Line of Credit Account gets closed as Follows:

Above Transaction Reported in my TransUnion Credit Report as follows "Balance 0.00, Closed on Consumer Request." Even when I asked TransUnion for accuracy of their report they did not make any change for the way it is being reported. Though bank tries to argue this means that the Bank "Written-Off" the account, bank failed to produce any evidences for their argument and the truth is "Money was Collected Towards" my Line of Credit. Bank account details should be able to tell from where this money was Collected from.

Also when my Chequing account with TD started to become Over Draft due to some accounting charges, after 4 months the Account gets closed as Follows:

Date Transaction Details Amount Balance

06/28/2005 **Collection Item** 107.30 CR

06/28/2005 Close Account 0.00 DR 0.00

TD Canada Trust may try to argue this also means that the Bank "Written-Off" the account. But TD Canada Trust eventually should tell where all these money were Collected from.

Also when I stopped payments for my TD Emerald Visa Card bank supposed to Write-Off the account in 180 Days (6 Months). In Court Documents TD Canada Trust say they Written-Off the account in 240 Days (8 Months). But Evidence (Account Details Provided by TD Canada Trust and TransUnion Credit Report) indicate account was Written-Off only after 540 Days (18 Months). This may be because the concealed account (or Any other form of Assert) provided security for my Visa Card loan amount. The money was in concealed account may have been disposed Illegally before write-off of the Visa account.

I tried to communicate with TD Canada Trust regarding this issue between 12th March 2007 and 17th October 2007. When I failed to receive responsible explanations I filed a Civil Claim on 18th October 2007 in Ontario Civil Court asking complete account details managed under my name in TD Canada Trust. Details of Civil Action is KIRITHARAN VS TD CANADA TRUST, Court File Number: 07-CV-341987PD 2. If you like to know more about the Case you can contact me and I am happy to provide more information to you.

As the incident happened may be violation of several sections of Canadian Criminal Cord, I made a police complain to Toronto Police Department regarding this matter. The complain number is: Fraud Complaint # **2529262.** But Police failing to make further inquiry saying

- 1. Opening a Bank account in another person name impossible in Canada.
- 2. Whether my Line of Credit is Paid or Written-Off is a Civil Matter between me and Bank.
- 3. As the Opening of Account may have happened in Ottawa, it is difficult for them to investigate.

I filed the case without lawyer. When TD Canada Trust failed to produce documents as needed by law, I requested court intervention and Court issued two orders. Even after that TD Canada Trust fails to make full disclosure and failing to respect some court orders. Thank you for your recent letter to the Superintendent of Financial Institutions concerning TD Canada Trust. Superintendent Julie Dickson has asked that I reply on her behalf.

The Office of the Superintendent of Financial Institutions (OSFI) is responsible for the regulation and supervision of federally registered financial institutions. We monitor and examine financial institutions for solvency, liquidity and safety and soundness.

Although I realize that you are experiencing a great deal of stress, I regret to inform you that OSFI does not have the authority to intervene in contractual disputes between a federally regulated financial institution and its customers. Pursuant to section 22 of the Office of the Superintendent of Financial Institutions Act, we cannot provide or disclose confidential information obtained from a financial institution, or regarding persons dealing with the financial institution, as this information is to be treated as confidential and may not be disclosed to a third party.

Similarly, we are not in a position to opine on a financial institution's internal procedures.

I note from your correspondence that you have taken legal proceedings against TD Canada Trust. Therefore, any information you require from the company should be obtained as part of the court proceedings (i.e., discovery).

Although I know this explanation may not help to ease your concerns, I hope that it will clarify OSFI's role in this matter.

Thank you for your correspondence regarding your dealings with The Toronto-Dominion Bank (TD Bank).

First, let me begin by explaining the role and mandate of the Financial Consumer Agency of Canada (FCAC). FCAC oversees federally regulated financial institutions to ensure that they comply with federal consumer protection laws, regulations, codes of conduct and public commitments.


Although FCAC appreciates the seriousness of your concerns, it has no jurisdiction over fraud, contractual disputes or the day-to-day operations and decisions of banks. Banks determine their own policies and procedures with respect to the servicing of customers and their accounts.

As you know, fraud falls within the jurisdiction of the police, which I note that you have contacted.

FCAC's role is to deal with compliance with the law; for consumers to obtain individual redress or compensation for losses, consumers must follow a bank's complaint-handling process. By law, all banks must have a process to help resolve disputes with their customers. In addition, the process offers the possibility of having the matter reviewed by an independent third party called the Ombudsman for Banking Services and Investments. I enclose a copy of TD Bank's process for your reference. Alternatively, consumers can also seek redress through a court of law, which it appears that you are now doing.

If you require legal advice, you may wish to contact a lawyer. The Law Society of Upper Canada offers a lawyer referral service for individuals who have questions about their legal rights. For \$6, the service provides you with the name of a lawyer who will offer up


